## **Privacy Policy**

## 1. Introduction

CP Group is a global logistics service provider, with a strong focus on logistics and additional services for the shipping sector, chemical and petrochemical industries and paint manufacturers. ### 2.1 General

You can withdraw your consent at any given time.

## 2.2.1 Purpose of processing personal data

CP Group uses your personal information in a number of ways to offer you the expected service. As written below in more detail. We will collect your consent prior to processing your data where required by applicable law.

### 2.2.2 Sharing personal data

If needed we will use contracts that ensure that processing is in accordance with the highest security regulations.

Service Providers: We rely on third parties to provide services and products on our behalf and may share your personal information with them as appropriate. Generally, our service providers are contractually obligated to protect your personal information and may not otherwise use or share your personal information, except as may be required by law. However, our fraud detection service providers may use, but not share, your personal information for fraud detection purposes. We may use service providers to communicate news and deliver promotional and transactional materials to you on our behalf, including personalized online and mobile advertising in accordance with your preferences and applicable law. CP Group will only work with parties that offer a method to opt-out of such advertising.

Transactions: As we develop our business, we might sell, buy, restructure or reorganize businesses or assets that is currently part of our portfolio. In such circumstances, we may transfer or assign information collected, including, without limitation, other information and personal information, to one or more affiliated or unaffiliated third parties in connection with these business transactions. To the extent that the law require it, we will provide notice of our intent to transfer personal data to a third party for this purpose, and explain how you can object to such transfer.

In addition, CP Group may disclose personal information in order to: (i) comply with applicable laws, (ii) respond to governmental inquiries or requests from public authorities, (iii) comply with valid legal process, (iv) protect the rights, privacy, safety or property of CP Group, site visitors, employees or the public, (v) permit us to pursue available remedies or limit the damages that we may sustain, (vi) enforce our websites' terms and conditions, and (vii) respond to an emergency.
